The Conception of Rushmore

Mike always had a passion for teaching; just ask his younger siblings. He started his teaching career as a tennis professional and moved into full-time teaching at the University of Arkansas after obtaining his PhD at Oklahoma State University. While a business professor he felt he would be a better teacher if he actually ran a business. So he started a small consulting business. After seven years teaching in the University setting Mike left traditional higher education and pursued his business in adult education. Over an 11-year period, the MBA Corporate Education Group delivered nontraditional education to more than 5000 AT&T and Lucent Technology employees and over 6000 employees from other companies.

While teaching entrepreneurship at one of the seminars one of the students asked if they could get college credit for these courses. Wanting to bring the best services available to his customer Mike started researching the possibility. Below is a description of what transpired in Mike's own words:

"I investigated the possibility of teaching entrepreneurship, marketing and management at a traditional university. After considerable study, I decided that large, non-entrepreneurial, bureaucratic, non-profit, traditional MBA programs were not meeting the needs of many business people. I subsequently investigated the field of nontraditional education and saw the tremendous benefits that nontraditional students were realizing. I began to realize that I had used nontraditional distance education methods to help me learn how to succeed.

"In 1996 I decided to start Rushmore University and create an organization that would be entrepreneurial and creative, not inflexible and bureaucratic. I designed the Rushmore program to make it possible for you to use distance-learning methods that fit into your busy lifestyle and permit you to learn at any time and at any place via books, video and audio media, software. A few years later the Internet became more accessible to worldwide students. Distance-learning methods also fit into the busy lifestyles of our Faculty; they counsel you from wherever in the world they happen to be.

"When I started Rushmore University, my main concern was developing Master's and Doctoral programs that would offer you substantial advantages and features that were not offered by traditional programs. My goals were to create programs that that did not waste your time by requiring you to study what you already know or do not need to know, as well as to increase your writing and research skills. This demanded that we structure a totally flexible program."

By listening to his customer and trying to provide extra services to a customer he already had, a whole new business was started.

Payments, Credits, and Guidelines

Dan Dolejs, our Director of Admissions and Records is one of the truly unsung heroes on Staff at Rushmore. Dan is the first person met by most students, and is often the last person with whom the student communicates after graduation.

His easy going attitude, helpful demeanor, and quick personal response time have been noted over and over by students and alumni as one of the things they enjoy most about their Rushmore experience. Here are his comments for November.

At Rushmore we like to be flexible in everything we do and that includes tuition payments. When I monitor the accounts my aim (it should be yours too) is that when you are halfway through your program you should have paid half your tuition fees, when you are three-quarters of the way you should have paid three quarters of your fees and so on. When you want a break from your studies you should notify your Advisers and if you want to suspend your payments you should notify me.

Of course the faster you pay your fees the less you will pay overall. If you want to pay in a lump sum to complete your tuition payments I will ensure that you get the discounts you would be entitled to. For example if you start your payments on a 3 year payment plan and then are able to make your payments in full after 2 years you will receive the tuition rate that applies for the 2 year payment plan. Everything is calculated from the day you enroll.

You can change credit cards at any time simply by sending me your credit card details via the secure link on our web site. Be sure to put something in every box (even if it means putting "N/A" – not applicable) before you click on the "Submit" button. After you have done this, a warning message may appear on your screen. This occurs because our credit card processor is not on the

Mainland USA. Rest assured it is still a secure link as all the information is encrypted.

The Rushmore guarantee allows for a full refund within 30 days of enrollment. After that refunds are allowed only for the pre-paid portion of your tuition. For example if you pre-pay all your tuition and then withdraw after 3 months you would pay for 3 months and have the remainder refunded. Keep in mind that Rushmore is a university not a bank. The money you pay is credited to your account to pay your tuition fees. It is not there for you to withdraw at random. However the money you pay will always be held in credit for you when you resume your program. It can also be transferred to another student.

If you are paying by Check, Bank Draft or Wire Transfer be sure to let me know the details of your payment so that I can credit your account. This is very important because if I cannot read your signature then I cannot credit your account. By all means ask me to confirm the receipt of the funds you send. Keep a record of your payments. Discrepancies are rare but when they occur it is useful for us both to be able to trace missing payments and the information you supply can assist us in that process.

ASEAN Foundation Scholarship

The ASEAN Foundation, an initiative of the Leaders of the Association of Southeast Asian Nations (ASEAN), was established on 15 December 1997 to help bring about shared prosperity and a sustainable future for the peoples of all ASEAN countries that now include Brunei Darussalam, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand and Viet Nam. It has been mandated to promote greater awareness of ASEAN and greater interaction among its peoples and their increased participation in ASEAN activities as well as to undertake development cooperation activities that enhance mutual assistance, address equitable economic development and reduce poverty. This scholarship programme is part of the ASEAN Foundation Scholarships for Postgraduate Studies and funded through the Japan-ASEAN Solidarity Fund.

Four (4) scholarship slots will be awarded under the project "Capacity building for Gender, Poverty and Mobility Analysis of Road Transportation Development in GMS Region". Echoing Green awards two year fellowships to emerging social innovators. Fellowships are awarded to individuals with innovative ideas for creating new models for tackling seemingly unsolvable social challenges. These fellowships offer them the opportunity to develop and test their ideas. Fellows do not develop their ideas in an academic setting.

but rather work in the community. They launch, manage, and grow organizations that implement and continually expand their ideas for creating lasting social change.

The fellowship includes a two-year, \$60,000 stipend (\$30,000 per year), health care benefits, online connectivity, access to foundation's network of social entrepreneurs, training, and technical assistance. Individuals who apply as partners (no more than two people) can apply for two fellowships combined for a total stipend of \$90,000 over two years.

Postdoctoral Fellowship In Global Change - Johns Hopkins University

The Johns Hopkins University invites applications for the Cormack Postdoctoral Fellowship in Global Change. This fellowship is part of a new Global Change Science initiative with the Department of Earth and Planetary Sciences.

We seek an outstanding individual with a recent Ph.D. who is pursuing interdisciplinary research in Global Change. Candidates whose research spans the physical sciences, social sciences, health sciences and/or public policy aspects of global change are preferred. Areas of interest include but are not limited to (1) fundamental processes driving global change; (2) the impact of global change on air quality, water resources, ecosystems, and/or human health; (3) remediation of the effects of global change; (4) energy resources; and (5) analysis of economic, sociological, public health, and policy implications of global change. Special consideration will be given to candidates who will collaborate with faculty from other Hopkins departments.
