Dear Ran,

I hope this can sit in your inbox until your successful return from Alaska.

I feel I owe you some further explanation for my inquiry about your quote on Earl de Blonville's soon to be republished book, 'Savage Coast'.

I have been interested in Earl de Blonville's career and professional claims since June of 2013 when I wrote him and asked if he could expand on the events that led him to write, in late May of 2013, this endorsement on LinkedIn for another explorer, Ripley Davenport. I had been following Ripley Davenport and fact-checking his claims since 2011 and had determined with extensive documentation, that Mr. Davenport was a fraud. Specifically, Mr. Davenport (and his wife) had invented a whole string of "expeditions" that had never happened, but whose description on his website gave Davenport the appearance of an accomplished explorer and with that appearance, entree to sponsors, news coverage, interviews, etc. Assuming that Mr. de Blonville was, as his website suggests, an authentic "Author, International Speaker, Founder: Postformal Leadership" I wanted to determine if perhaps my research was fatally flawed. Here was an endorsement of such glowing terms, such personal investment from an apparent icon of Australian exploration. Could I be totally mistaken in my conclusions about Ripley Davenport?

Mr. de Blonville's response was to threaten to send unnamed minions to my home in Montana and beat me up (several times no less) for having the temerity to ask what part of reality the endorsement was based upon. There is no evidence that Mr. de Blonville has ever met Ripley Davenport in person, much less traveled or worked with him.

The outrageous and unprofessional nature of Mr. de Blonville's response to my inquiry piqued my interest in a "doth protest too much, methinks" way. I am of the certain opinion, having done considerable fact-checking on Mr. de Blonville's professional claims, that his primary skill is self-promotion and his current career, such as it is, runs on the fumes of the nearly disastrous '86 expedition chronicled in 'Seventh Journey' (soon to be resurrected as 'Savage Coast'). Seventh Journey never stirred interest with a publisher so Mr. de Blonville was forced to self-publish it in a run of a few hundred copies. I have one of those rare tomes and have read it, though none of the other participants in the '86 expedition have read it or were consulted on the draft.

I also believe he is guilty of fraud relative to his application to a doctoral program at Royal Melbourne Institute of Technology in 2011. I won't drag out that long story or the rest of the details of the research. The Google will lead you there if you are so inclined.

Getting back to your quote for the jacket of 'Savage Coast'. My interest was piqued because Mr. de Blonville has a track record of linking himself to genuinely accomplished people as promotion for his various commercial schemes. Case in point is a recently defunct business called gesiles in which de Blonville proposed to take accomplished, wealthy business people aboard a 100 year old sailboat and impart leadership wisdom through salt spray and French cuisine. Included in the Adjunct Faculty were, among others, Chris Bonington and Robin Knox-Johnston. Upon inquiry, neither of those gentlemen expressed familiarity with the program in which they were advertised as participants nor did they acknowledge having given permission to be represented as such. They expressed only passing knowledge of Mr. de Blonville. A similar pattern exists in other schemes of Mr. de Blonville's.

So that's why I wondered if you had actually read the book before agreeing to provide a quote. Since 'Savage Coast' is not actually published yet, you must have read a copy of 'Seventh Journey'. Or, perhaps your quote is the result of having traveled with Mr. de Blonville and knowing him as a personal friend.

As I told Mr. de Blonville when I inquired about his endorsement of Ripley Davenport, I'm not a martinet on a mission to nit-pick. Had he acknowledged that he wrote a fantasy endorsement for a fan, the story would have ended there. I understand that lots of quotes on lots of books are from people who didn't actually read the book or skimmed the book or quoted based on having an idea of what's in the book. 'Seventh Journey' is 415 pages, after all. I understand the universal nature of back-scratching so I'm not out to pillory anyone for having taken a short cut. And I'm confident you won't be threatening to have me beaten up for asking the question.
