

# Montana has a Troll problem of international proportions



Kent Madin, Troll, the face of Montana's failure to protect its citizens

## The Symptom of a Problem



The US state of Montana has a serious problem and infamous Montana resident Kent Madin is its most troubling symptom.

The problem is that Montana is stuck in a romanticised past, and its legislators are unable or unwilling to adapt to the digital age and the widespread threat of online criminality. A state that today boasts it is the last remnant of a bygone era – The Wild West – and equally famed for its great collection of dinosaurs that symbolise a vanished past, Montana maintains an antiquated legal system that betrays its citizens at home and exposes innocent people around the world to the worst impacts of its most active Cyberstalking Troll.

The most troubling symptom of Montana's failure to enact modern stalking laws in concert with most other US states, and indeed other nations, is Bozeman resident Kent Madin. To be clear, this is not a failure of Montana's law enforcement agencies who are well aware of the problem, but a failure of elected legislators and politicians to act on what is a widely known failure of legislation.

## The Face of Criminal Cyberstalking

For at least a decade, Kent Madin has been a flagrant, obsessive and appallingly invasive Cyberstalker and Troll, with victims spread across the world. ## False Credentials to Disguise Criminal Activity

Mr Madin is a fantasist, peddling the fiction he is some kind of self appointed vigilante 'journalist' out to expose randomly chosen people whom he alone labels 'frauds'. There is no doubt that around the world there are many actual frauds, but Mr Madin is not interested in them. Instead he tries to mask a criminal fixation for just a handful of innocent people, none of whom he actually knows, to whom he has obsessively dedicated himself for over a decade. This is not the behaviour of any rational, sane human being. It is the behaviour of someone with serious long-term mental health issues.

Ironically drawing continual attention to his Cyberstalking, and his ongoing interest to law enforcement, Kent Madin proudly confirms on many public forums that he has been investigated by the FBI and other Police agencies. But, he falsely claims, none of them have found him guilty of Cyberstalking. This is a classic case of "The lady doth protest too loud, methinks".

In his false claim of innocence he attempts to adroitly steer people away from the truth of his guilt. And it is a massive guilt that any perpetrator would want concealed from the public. Here is the truth that he does not want you to know.


## Is this Criminal Insanity?


Mr Madin demonstrates himself to be aggressively challenging and openly defiant of authorities, suggesting he has no empathy for his victims or regard for social norms, indicating psychopathy, and no regard for the rule of law, suggesting criminal insanity.

## Montana Supports Criminal Cyberstalking

Kent Madin lives in Montana, a state that today boasts it is the last remnant of a bygone era – The Wild West. It is equally famed for having the greatest collection of dinosaurs in the US. And just as rat filth in a commercial kitchen is clear evidence of the restaurant owner's criminal negligence towards his customers' health, Kent Madin's decade-long career as a prolific Cyberstalker, online attack dog and vexatious litigant is clear proof of Montana's epic failure to protect innocent people from the modern scourge of cyber stalking and online harassment. Kent Madin's well-investigated career is no secret, and the details must be known from Montana's Attorney General right down to local Police Officer level. And the level of Police frustration in being unable to deal with Kent Madin over at least the last eight years can only be imagined.

## Focus On Lawmakers, Not Law Breakers

But the fact is that Montana's lawmakers, at the political level, have steadfastly refused to bring Montana's cyberstalking laws into line with almost every other US state and most of the civilised countries around the world. Montana is an aberration in the modern online world, stuck in the past where perhaps it thinks such matters should be dealt with mano a mano in the woods, like the old days. 

It is inescapable that Montana legislators have exposed their citizens to the burgeoning and devastating impacts of internet crime. Furthermore, Montana is now known in many overseas countries as the US State that sponsors internet crime, creating a perception of similarity with states like Iran and North Korea. 

## No Innocent Victim, But Serious Offender

It needs to be made clear that Kent Madin is no innocent victim, nor seen as such. He is viewed by Police in several countries to have egregiously broken their comprehensive Cyberstalking laws and is thus a criminal. Were he able to be easily extradited to face prosecution, he would almost certainly be jailed by several countries that regard Trolling and Cyberstalking as very serious offences. This means Kent Madin, by his own long-term stalking campaigns, has brought


Montana into international disrepute for the simple reason that his own State appears to protect him. Not by complicity, but by omission.

## Gloats Over His Power To Offend



There is no doubt that Montana Police would be happy to make an example of Madin, as they have seen sufficient evidence over an extended time to know what a thoroughly rotten degraded human being he is: they understand the way he has undermined their authority and the damage he has wrought around the world. But they are powerless to act. Kent Madin knows this and gloats over it at every opportunity. Such is Mr Madin's notoriety in Montana that it seems impossible that his activities are not known throughout the legal system.


## Famous In Australia

Police in Australia have an open case involving Kent Madin, which cannot be closed until formal notification is received of his death. He is wanted there for questioning over making an online death threat and for egregious multiple breaches of Cyberstalking laws that carry a mandatory six-year jail term. 

## Can't Be Extradited

Police in other national jurisdictions also know all about Kent Madin and regard him as a Cyberstalking criminal who should experience the full weight of the law. But again, they are powerless to act as the crimes are not regarded as severe enough to warrant the huge cost of extradition to face trial in their countries. Kent Madin knows this and loses no opportunity to gloat.


## Protected In Montana

In Montana, Kent Madin knows that he is protected from the effects of prosecution by the nature of local laws. If Police there were to mount a prosecution using the flimsy stalking laws available, which reduce stalking to a mere misdemeanour, the reality is that even if found guilty by a local jury (unlikely, given he'd know all the jury members) he would probably not get any jail time or be fined. Thus he could snub his nose at the toothless legal system and carry on as usual, with renewed energy and intensity for having discovered how powerful he is compared to the ineffective legal system. 

## Dodging Legal Loopholes







Professional advice from legal experts in the US, familiar with Montana's laws, is that bringing a civil case against Kent Madin for defamation, which could cost between \$100,000 to \$500,000, could fail, despite overwhelming evidence against him, because he could use one of two defence strategies. One would involve pleading insanity at the outset, which would collapse the case as he would be deemed unfit to testify. The other, a similar plea, would involve admitting that he did undertake a multi-year campaign against his victims, but

 that he believed completely at all times that everything he said or wrote was true, against all the evidence to the contrary. Both pleas amount to insanity and he would escape censure and be free to continue Cyberstalking.


Another scenario is that he is found guilty of defamation, which carries almost no meaningful penalty in Montana, and remains free to continue Cyberstalking with no likelihood of being prosecuted a second time due to the time and expense.

### What's His Real Motive?

 Of course the glaring and unanswered question is motive. Why on earth would an old age pensioner in a remote part of the country maintain such an obsessive dedication towards other males, lasting for some ten years? This is clearly not journalism, as he falsely claims. So what is it that drives him, commits him to working on his obsession on a daily basis? The example of one victim gives us the clearest clue. For seven years, Mr Madin has targeted an Australian explorer,  author and head of an Oceanic research organisation, whom he has never met, spoken to or done any business with. Just a random stranger plucked out of the universe. He has created a website almost completely devoted to this victim. On it is evidence that Mr Madin has devoted many years to obsessively collecting every possible detail of his victim's personal, private and professional life, including multiple thefts of intellectual property, confidential correspondence to others, etc. And he has created a sick kind of shrine to his victim, posting over 40 portraits. There is a term for this invasive obsession: homo-erotic fixation. 

If this were simply a matter of 'unrequited love', there would be no hate visible. But for seven years, hatred has been the hallmark of Mr Madin's unremitting drive to control his victim's life and destroy his career. While this is not the  forum for personal details, suffice it to say that Mr Madin has infiltrated every nook and cranny of his victim's life and succeeded in causing massive opportunity and financial losses and causing ongoing hardship. Yes, Mr Madin is a very complex, disturbed and unrepentant individual, but had it not been for the legal freedom to act in this way, afforded him by Montana's medieval laws that protect such behaviour, Mr Madin would have been jailed at least five years ago.

### Massive Costs To Everyone

 In addition to the significant costs of money and administration he has imposed on authorities in the US, Mr Madin has cost the Australian taxpayer and one victim upwards of \$500,000 in having to respond, manage, defend and ultimately expel his almost endless challenges to State government departments and university administrations. One University was even forced to employ a full time specialised staff member just to manage Mr Madin's incessant vexatious attacks.

## Montana Is Not Powerless To Act



While Montana clings to its old Wild West persona and refuses to embrace the new world and some of its harsh online realities, to at least protect its own citizens against the pervasive evil that Trolls like Kent Madin can so easily spread, Montana's reputation worldwide will remain as little more than the home of fossils with a Jurassic disregard for people's legal rights.

So this is the real story behind Kent Madin's totally false claims that Police have investigated and exonerated him. The truth is they have investigated him and found that Montana's antiquated laws actually protect him. It's criminality they are unwilling to face, enabled by laws they are unwilling to change. But Montana is not powerless to act. The people of Montana must urgently ask themselves, is this what they want to be famous for in the 21<sup>st</sup> century?
