Dear Linda,

My name is Basha O'Reilly. I am a British citizen, a Fellow of the Royal Geographical Society, the Explorers' Club, the Scientific Exploration Society and the Founder of the Long Riders' Guild, the international association of equestrian explorers.

I don't suppose you remember me, but I booked a riding holiday in Romania with Boojum in 2000. Then I met CuChullaine, now my husband, and you kindly agreed to cancel my booking and refund my money.

In addition I am a publisher, a grandmother – and the latest victim of your husband Kent who has terrorized the exploration community for many years.

He has tormented more than 120 victims in six countries, and has deliberately misused his status as a diplomat so as to carry out a campaign of cyber-terror.

Kent has sent unwanted and offensive emails or tweets to many of his victims, their friends and family, their work colleagues and/or associates; published private and confidential information online and has continued to write unwelcome emails, even after being told that the victim does not want to be contacted again.

I attach a document which explains how he has attacked explorers, their loved ones and their sponsors. He has demanded access to their passports and attempted to steal their medical records. He has obtained confidential information from the public by disguising himself as an "investigative journalist." He has cloaked his cyber activities under the guise of his role as an Honorary Consul. He has persecuted sponsors and caused such fear that expeditions have been cancelled.

Over the last four years he has attacked, stalked, harassed, bullied or spied on Members of the Long Riders' Guild and Fellows of the Royal Geographical Society and Explorers' Club. I also attach statements from more than a dozen explorers, their family members, their sponsors and prominent members of the American press.

I am writing to ask the Madin family to stop the torment.

**What I want is simple. I want Kent Madin to cease all contact with me, and anyone associated with me. I want the cyber squatting websites to be taken down. If this happens at once, I will consider dropping my request for his arrest by the FBI and the Montana State Attorney.**

No matter where his victims live, they have a fundamental right to be free from fear and persecution from this man.

In closing, please be advised that I believe I am in danger and I am requesting your help as a fellow human being to protect me from your husband.

I look forward to hearing from you.
